

James Moffett of Scout International **UMBWX** shares Jain's reluctance to invest directly in China, but because of doubts over corporate governance and legal protection, not out of concern over economic growth. Therefore, while Moffett has avoided Chinese stocks entirely, unlike Jain he has specifically sought exposure to China's rapid growth through overseas stocks such as BHP Billiton and Komatsu.
